 - (a) If you are an individual member, please sign where indicated.
 - (b) If you are a corporate member which has a common seal, this proxy form should be executed under seal in accordance with the constitution of your corporation.
 - (c) If you are a corporate member which does not have a common seal, this proxy form should be affixed with the rubber stamp of your company (if any) and executed by:
 - (i) at least two (2) authorised officers, of whom one shall be a director; or
 - (ii) any director and/or authorised officers in accordance with the laws of the country under which your corporation is incorporated.

 An online meeting platform can be recognised as the meeting venue or place under Section 327/2) of the Companies Act 2016 if the online platform is located in Malaysia and all meeting participants including Chairman of the meeting, board members, Key Senior Management and shareholders are to participate in the meeting online. Bhd. to make available to the Company, a Record of Depositors as at 22 November 2024. Only a member whose name appears on this Record of Depositors shall be entitled to Participate at this 7th AGM via RPV or appoint a proxy to Participate on his/her/its behalf.
- A member entitled to attend and vote at this 7th AGM via RPV is entitled to appoint a proxy or attorney or in the case of a corporation, to appoint a duly authorised representative to Participate in his/her/its place. A proxy may but need not be a member of the Company.
- A member of the Company who is entitled to attend and vote at the 7th AGM of the Company may appoint not more than two (2) proxies to Participate instead of the member at the AGM.
- 5. Where a member of the Company is an authorised nominee as defined in the Securities Industry (Central Depositories) Act 1991 ("SICDA"), it may appoint not more than two (2) proxies in respect of each securities account it holds in ordinary shares of the Company standing to the credit of the said securities account.
