#### REGISTRATION ON THE DAY OF THE 8TH AGM

- Registration will commence at 9.00 a.m. on 28 November 2025 and will remain open until the conclusion of the 8<sup>th</sup> AGM or such time as may be determined by the Chairman of the meeting.
- Please present your original National Registration Identity Card ("NRIC") or Passport (for non-Malaysian) to the registration staff for verification.
- Upon verification, an identification wristband will be given to you for voting purposes thereafter. No one will be allowed
  to enter the meeting hall without an identification wristband. There will be no replacement for the identification
  wristband if it is lost or misplaced.
- Registration must be done in person. No person is allowed to register on behalf of another even with the original NRIC or Passport of the other person.
- The registration counter will handle verification of identity, registration and revocation of proxy/proxies.

### **GENERAL MEETING RECORD OF DEPOSITORS ("ROD")**

• Only a member whose name appears on the ROD as at 21 November 2025 shall be entitled to attend, speak and vote (collectively "participate") at the 8<sup>th</sup> AGM or appoint proxy(ies) to participate on his/her/its behalf.

### **CORPORATE MEMBERS**

- Corporate members who wish to appoint corporate representatives instead of proxy(ies), must deposit their original certificate of appointment of corporate representative to Tricor Investor & Issuing House Services Sdn. Bhd. ("Tricor") before the 8<sup>th</sup> AGM or bring the original certificate of appointment of corporate representative to the 8<sup>th</sup> AGM.
- Attorneys appointed by power of attorney are required to deposit their power of attorney with Tricor not later than 26 November 2025 at 10.00 a.m. to attend and vote at the 8th AGM.

### **PROXY**

The appointment of proxy(ies) may be made in hard copy form or by electronic form in the following manner and must be received by the Company not less than forty-eight (48) hours before the time appointed for holding the 8<sup>th</sup> AGM or adjourned AGM at which the person named in the appointment proposes to vote, otherwise the Proxy Form shall not be treated as valid:-

### a. In hard copy form

In the case of an appointment made in hard copy form, the proxy form must be deposited with the Company's Share Registrar, Tricor Investor & Issuing House Services Sdn. Bhd. at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur or the designated drop box located at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur.

### b. <u>By electronic form</u>

### **ELECTRONIC LODGEMENT OF PROXY FORM**

A confirmation email will be sent once approved.</li> <li>Once you receive the confirmation, activate your account by creating your password.</li> </ol> If you are an existing user with The Portal or our TIIH Online portal previously, you are not required to register again.
Proceed with submission of proxy form	<ol> <li>After the release of the Notice of Meeting by the Company, login with your email address and password.</li> <li>Select the corporate event: "MTAG GROUP BERHAD 8<sup>TH</sup> AGM".</li> <li>Navigate to the 3 dots at the end of the corporate event and choose "SUBMISSION OF PROXY FORM".</li> <li>Read and agree to the Terms and Conditions and confirm the Declaration.</li> <li>Indicate the total number of shares assigned to your proxy(s) to vote on your behalf.</li> <li>Appoint your proxy(ies) and insert the required details of your proxy(ies) or appoint the Chairman as your proxy.</li> <li>Indicate your voting instructions – FOR or AGAINST or ABSTAIN.</li> <li>Print the proxy form for your record.</li> </ol>
ii. Steps for Corporation or Institutional Shareholders

A confirmation email will be sent once approved.</li> <li>Once you receive the confirmation, activate your account by creating your password.</li> </ol> Note: The representative of a corporation or institutional shareholder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact Tricor if you need clarifications on the user registration.
